## **Design Guidelines**

The Neighborhood Plan adopted last year into the City's 2040 Comprehensive Plan recommends developing design guidelines to address potential adverse impacts of new construction on neighboring properties and preserving the character of the neighborhood. Recent West End Citizens Association newsletters and emails have covered the startup stages of the West End Design Guidelines initiative. Here is our progress update:

Neighborhood Design Guidelines Survey A survey was circulated to the West End community in the May 2022 West End Citizens Association newsletter, community emails, and a City of Rockville mailing to West End households. Thank you to all neighbors who completed the survey! Responses corroborated the results of the 2016 survey for the Neighborhood Plan, and showed that neighbors:

- Support allowing new construction while minimizing its impact on neighbors (e.g., stormwater runoff, solar access)
- Want to preserve the park-like quality of the neighborhood and its balance of open space to buildings
- Value trees and green space in front and back yards

#### Drafting the Guidelines

The West End Design Guidelines committee, which formed last year after several rounds of outreach to the neighborhood, has met throughout 2022 to draft West End Design Guidelines. The drafting process uses the Neighborhood Plan and the feedback from the 2022 neighborhood survey as primary sources. The group reviews the East Rockville Design Guidelines document (which was approved by the Mayor and Council in 2021) as a precedent for format, updating it for West End neighborhood concerns and feedback. The drafted guidelines are reviewed by the City's Department of Community Planning and Development Services, and by the architectural and landscape architectural consultants supporting the project.

#### <u>Applicability</u>

The aim of Design Guidelines is <u>not</u> to suppress development or change existing structures, but to ensure that newly built homes or additions contribute positively to the character and environmental health of the neighborhood, and to promote complementary and contextsensitive development between new and existing structures while also allowing creative design.

#### **Opportunities for Feedback**

In addition to the neighborhood survey, we are conducting ongoing sessions for West End residents to provide feedback and ask questions.

- Two Public Outreach Sessions were held in August and September. Thank you to all who participated!
- The Fall General WECA Meeting on October 13 at 7 p.m. will include a Community Information Session on the Design Guidelines. We will share the neighborhood survey responses and draft Design Guidelines for comment and questions.
- An additional Public Open House will be held in December or January, where updated draft Guidelines will be presented for comment.

## WEST ROCKVILLE CONNECTS Village Developing Rapidly

It has been just under a year since the first informational West Rockville village meeting occurred. Since that time, the leadership of one of Rockville's newest villages is busy recruiting, planning, and strategizing the path forward.

Villages are grassroots, neighbor-governed support organizations that help people of all ages thrive in their communities. Villages offer a variety of services ranging from transportation to errands and social connectedness opportunities. Each village is unique and reflective of the ethos of the community they serve. Although there have been other attempts to form a functioning village in West Rockville, this new group has broadened the service area to include the neighborhoods of West End, Woodley Gardens, College Gardens, Plymouth Woods. Within the West End, the villages will reach out to embedded neighborhoods including Haiti and Rose Hill Falls. So far, there has been a coffee meeting at the Swim & Fitness Center, a meet & greet at Woodley Gardens Park, National Night Out campaigns and many planning meetings. Be sure to stay tuned for some upcoming events "pop-up" events in the works!

Rockville villages have been forming for many years. Today, King Farm has a fully operational village. Other villages are being formed across the city. It is important to note that the city neither dictates nor governs villages. They are independent entities. The Villages Facilitator, Trish Evans, offers resources and support of all types to assist in the development phases.

## Radon: Be Safe, Test Your Home

Radon is a radioactive gas that can cause lung cancer. It naturally exists in the atmosphere but can become trapped indoors. To protect yourself and your family, it is important to **test your house for radon and mitigate the problem if radon levels are high**.

Radon is the number one cause of lung cancer in non-smokers in the United States and can exacerbate lung cancer in smokers. The longer the duration of exposure, the greater the risk.

Radon gas is the product of uranium decomposing in the ground soil. This is a natural, ongoing process. The gas is detectable only through testing; it is silent, odorless, invisible to us, and cannot be felt. It permeates your house by leaking through crevices and cracks. The Montgomery County website has information, including maps, videos, and illustrations at: https://www.montgomerycountymd.gov/green/ air/radon.html. **High levels of radon have been found in homes in Rockville** but mitigation can reduce the level of radon significantly. The City of Rockville agreed to develop an awareness campaign and published "Rockville Urges Radon Awareness for Homeowners" in *Rockville Reports*, May/June 2022). https://www.rockvillemd.gov/2418/Radon. The mayor and council adopted energy disclosure and radon laws. The Rockville Housing Enterprises, the city's public housing agency, secured \$157,870 to support radon testing and mitigation demonstrations (see *Rockville Reports*, September 2022 issue).

Radon test kits are available in hardware stores and online from \$20 to \$100 and Rockville's radon webpage includes a link to order a \$3 test kit. It is best to test at a time of the year when your house has the least amount of ventilation, when windows are kept shut. Be safe, test your house for radon!

## **Neighborhood Items of Interest**

**Road Diets**: The City's plans to implement "Road Diets" is out for bid and includes reducing traffic lanes along North Washington Street and Middle Lane to a single lane in both directions and adds bike lanes and parallel parking spaces. The goal is to make these streets more business-friendly and safer/accessible to walkers and cyclists. We received the following update from the City regarding our concerns expressed last Spring:

<u>Vehicular Travel</u> WECA raised parallel parking as a potential contributor to congestion as traffic will have to wait for cars to maneuver into and out of spaces. City's Response: "City staff has asked the consultant to review the proposed parking spaces and minimize potential operational and safety impacts related to parking vehicles. Some on-street parking spaces might be eliminated, if needed, to ensure smooth traffic operations and safety along N. Washington Street and E. Middle Lane." <u>Reduced Safety</u> The plan presented to WECA last Spring did not include adequate space at all bus stops for buses to pull out of the traffic lane, which may result in frustrated drivers pulling around buses into on-coming traffic. City's Response: "In general, buses will be able to pull over to the curb, leaving enough space leaving enough space for cars to go around them while stopping at bus stops."

<u>Bicycle Path Barriers</u> WECA is concerned about achieving the best balance of bicycles, vehicles and pedestrians. While it is important to protect the safety of cyclists, WECA has questioned the use of concrete barriers between bike and car lanes; they are not used in other areas of the city. City's Response: "The Rockville Bicycle Advocacy Committee has recommended the barriers for the safety of bikers. The design consultant is proposing precast concrete barriers wherever it is necessary to ensure bikers' safety."

WECA continues to support the development of this area to be more business-friendly and safer/accessible to walkers and cyclists.
