PROPOSED ZONING CHANGES THAT WILL AFFECT YOUR PROPERTY

The City of Rockville is proposing two zoning changes. One would allow a second dwelling unit in backyards, known as Accessory Dwelling Units (ADUs), and the other would make it easier to have an apartment within existing single-family homes, known as Accessory Apartments.

An **Accessory Dwelling Unit** would be a second, smaller dwelling in the backyard of lots where only one house is allowed today. The dwelling would be permanently attached to the ground and have its own plumbing, electrical service, kitchen and bath. It could also be an apartment above a garage or other accessory building. ADUs are currently not permitted in Rockville; this proposed City-wide zoning change would permit them to be added to residential lots, with several conditions.

An **Accessory Apartment** must include a kitchen, bath and sleeping area. The Accessory Apartment may be created within the main house or by attaching an addition to the main house as long as the addition is subordinate to the existing house. Accessory Apartments are currently permitted in the City, with approval. Here is the key change to zoning on Accessory Apartments:

- <u>Current zoning</u> an Accessory Apartment must be approved through review by the Board of Appeals after notification of nearby households. Residents are allowed to testify for or against the proposed Accessory Apartment. This process is called <u>Special Exception</u>.
- <u>Proposed zoning revision</u> The City is proposing to allow approval of Accessory Apartments by city staff subject to conditions. The City would not be required to notify or consider neighbors' views. This process is called <u>Conditional Use</u>.

RPAC: MAKING IMPROVEMENTS ONE STEP AT A TIME

How can we make our streets safer for everyone? Why does the sidewalk end in some places? What is the best way to get a crosswalk installed? Members of the **Rockville Pedestrian Advocacy Committee (RPAC)** came together to address these questions, and many more. Formed in 2019 RPAC aims to make Rockville a safer, more comfortable, and easier place to walk and roll. All West End residents are welcome to attend and participate in RPAC's monthly virtual meetings.

In our neighborhood, RPAC partnered with WECA to advocate for a safer Maryland Avenue between South Washington Street and Falls Road. This "road diet" reduced the number and width of vehicle lanes and added bicycle lanes on both sides of the street - creating a protective buffer between pedestrians and vehicle traffic. The reconfigured roadway has greatly reduced drivers' illegal speeding with no impact on traffic flow. In the first nine months of the road diet, eastbound speeding tickets decreased by 72% over the prior year. Current or upcoming pedestrian improvements impacting the West End include the Town Center Road Diet and sidewalk feasibility studies on Nelson Avenue and Wood Lane. RPAC also has a critical voice in some of city-wide pedestrian and transportation efforts, including:

- **Vision Zero:** The goal of zero traffic-related deaths or severe injuries by 2030
- **Pedestrian Master Plan:** A guide to safe, convenient, and equitable pedestrian facilities.
- Walktober: A month long celebration of walking and rolling, including "Walk to School" Day.

Town Center Master Plan. The City of Rockville Department of Community Planning and Development Services intends to update the Rockville Town Center Master Plan, a long-range vision for growth and development. Information about the Town Center Master Plan update is at engagerockville.com/towncenter including a survey that EVERYONE is welcome to take. The results of the survey will help guide the future direction of Town Center.

West End Design Guidelines. Thank you to everyone from the neighborhood who took the survey or provided input about design guidelines. In January, City Manager Rob DiSpirito supported and presented to the Mayor & Council a request made by WECA for a temporary pause in the Design Guidelines process, in order for the City to address issues affecting the project, including improving project management, correcting the large number of errors and incomplete information in the posted Design Guidelines draft document, managing and providing access to the consultants hired for the project, improving the engagerockville.com website, and providing correct information about the project goals, content, process, and timeline. The Mayor & Council expressed support for this approach. We will continue to provide updates on the WECA website and via email.

Mrs. Sante was a founding member of the West End Citizens Association; a charter member of Peerless Rockville: a member of the Cultural Arts Commission; a member of the Historical Society; and a docent at St. Mary's Historic Church, the Beall-Dawson House and the Glenview Mansion. She also was a supporter and volunteer for Rockville Little Theatre and Rainbow Place. Peg and Julian, her husband of 51 years, lived on Beall Avenue and raised six children in our community (see inset picture); she passed away in 2002.

In recognition of her contributions to the community, and especially of her work as a

founding member of WECA, it is fitting that we continue to honor Mrs. Sante by using the likeness of her Beall Avenue home as our logo.

We would, however, ask the
